Speaking from personal experience, it is a pretty big commitment being on the CSEG executive and I would like to thank everyone for stepping up to the plate and representing our society!

At the AGM on March 19, I will be reviewing the year's accomplishments and I will also be including the highlights in the President's Executive Report. These accomplishments were a group effort and I believe the 2012 Executive was a smoothly running machine with great energy and a positive attitude.

The following is a listing and brief discussion of the highlights. I have also included the CSEG Mandate just to put things in perspective.

CSEG Mandate – The mandate of the Canadian Society of Exploration Geophysicists is to promote the science of geophysics, especially as it applies to exploration, and to promote fellowship and cooperation among those persons interested in geophysical prospecting.

Membership – The current membership sits at 2354 compared to 2104 last year. While we have seen increases in all areas of the membership, the biggest increase came in the student membership. This is most likely due to student membership sponsorship (presently covered by RPS Boyd).

Social Committees – This year we instigated new requirements for CSEG sponsored social committee events. That is, that to participate in a CSEG event, one should be a CSEG member (it's \$52.00). This requirement is not applied to spouses and some other special cases. We also saw the Women in Seismic Exploration (WISE) golf tournament become a CSEG sponsored event. We initiated the meritorious service awards that are given out at the CSEG Symposium and we established a yearly meeting for all the committee members to get together and compare notes on efficiencies and fund raising.

GeoConvention 2012: Vision – 2012 marked the first year that the CSEG operated the GeoConvention (CSEG, CSPG and CWLS) under the JACC agreement. The 2012 convention was an overwhelming success with a net profit going to the CSEG of \$460,000 (compared to \$406,000 the previous year). There were 247 oral presentations, 111 posters, 19 core displays and 4157 registered delegates. The CSEG is again operating in 2013 and all the early indicators suggest that this we will be an even more successful event.

Memorandum of Understanding (MOU) with the EAGE and SEG – Members of the Executive met with their counterparts at the SEG Convention in Las Vegas. The purpose of these MOU's is to put some structure around the existing society relationships. In particular, we will promote our respective societies at each

other's conventions, in our respectful journals and on our web-pages. While we presently host the DISC and EET programs, our Foundation Distinguished Lecturers (DLs) have not been promoted in Europe and in the US. We expect to have the MOUs signed at the CSEG Symposium, March 7.

CSEG Symposium – After a successful inaugural symposium, we will be moving ahead with the second annual CSEG Symposium on March 7, 2013. A full slate of invited speakers has been confirmed. This year's topic will be celebrating the accomplishments of Bill Goodway.

CSEG Foundation – The CSEG Foundation achieved the \$1 million mark and the beginning of 2012 partially thanks to the Society being able to donate almost \$250,000 two years in a row. Through a

new fundraising effort, the Foundation is now moving towards their goal of \$3 million. At last count they were approximately \$600,000 closer to that. This includes private donations and another society donations that should easily be \$300,000 this year. The next phase will be targeting corporate entities. The Foundation sponsors student scholarships, the Distinguished Lecturer tour, outreach, travel grants and learning subsidies.

CSEG Rebranding – The CSEG has completed a major new rebranding for the Society and the Social Committees. The new brand will be rolled out at the AGM while the social committees could take a bit longer.

We continue to offer the SEG Distinguished Instructor Short Course and have now partnered with the EAGE to offer the EAGE Education Tour courses. Both the Lunchbox Geophysics and the Microseismic User Group continue to offer high quality talks that often fill their venues to capacity. As for the monthly Technical Luncheons - we endeavoured to cover a wide range of topics from microseismicity to global geophysics, bringing in internationally renowned geophysicists including a number from our own backyard!

This could not have happened without a dedicated group of volunteers, a membership that is eager to participate, and sponsors willing to help defray some of the costs of these events. Perhaps just as important are the companies that encourage employees to volunteer and attend educational events as part of their professional training. Canadian geophysicists are world class and we all benefit by increasing our knowledge and understanding.

Over the past year, we endeavoured to capture the organizational duties of these committees in the form of a "Structure and Guidelines" document, prompted by the fine example prepared by the Symposium Committee under Satinder Chopra (2012) and Oliver Kuhn (2013). Key aspects include objectives, roles, timelines and succession planning. This will no doubt improve the professionalism of our committees, but also allow volunteers to better manage their time with

a finite commitment in mind, and offer volunteers more opportunities to move to different committees if they so desire.

In past annual reports, the Director of Educational Services has provided a summary of all the Committees under report. As part of the "Structure and Guidelines" document, we have requested that one of the roles of the committees is to prepare a short summary for the annual report. Thanks to all the committee chairs for their timely submissions. The CSEG is indeed fortunate to have very capable and dedicated volunteers as committee chairs and members. On behalf of the members, I would like to thank all of you for your efforts.

Last, but not least, I would like to thank Sheryl Meggeson and Jim Racette for their infinite patience and wisdom, and for their guidance and assistance in all things concerning the CSEG. It has been a pleasure working with you.

### **CSEG Financial AGM**

The CSEG has had a very successful year in many aspects with the financial results being one of them. The financial side of the CSEG has been well looked after by previous Directors of Finance so I took over a well-run operation and built upon it. Last year was an excellent year as well resulting in a surplus of funds that was given to the CSEG Foundation in January of this year. This year we ended up in the red due to another large donation being made to the CSEG Foundation prior to the end of the year. If you take both years together we have broken even as a nonprofit organization should. The timing of the donation for 2011 was in January of 2012 which impacts the 2012 results. This is evident on the financial statements as the surplus for 2011 approximately equals the short fall in 2012 around \$250,000. Due to having to make a decision on the amount at our December Executive meeting prior to year end the amount will not match exactly. Our financial reserves

have been preserved with the society having ample reserves to carry the society through years when the industry is struggling.

The CSEG runs most of its programs on a breakeven basis although this can swing from a small loss to a small profit depending on how the attendance compares to our forecast. This year saw the launch of a new event, the CSEG Symposium that was budgeted for a breakeven scenario although with the excellent turnout it generated a small profit. This was due in large part to the great leadership of the event. We have some activities for which there is no income like our CSEG office space. Our main revenue generators, in addition to our membership fees, are the annual joint convention (CSEG, CSPG & CWLS) and the Doodle-Train week in November. Both events are run mostly by volunteers. The convention has two paid staff to run the day to day

tasks although it is the many volunteers who plan, organize and staff most of the convention activities that lead to its success. The DoodleTrain is also staffed by many volunteers and aided by corporate donations such as classroom space. The course offerings and attendance were up this year.

My two year term with the first year as Assistant Director of Finance and then this year as Director of Finance for the CSEG is up after the Annual Meeting. I have enjoyed the opportunity to serve the society and you over these two years. I leave you in capable hands as our current Assistant Director of Finance, Wade Brillon, will take over my role after the Annual Meeting in March.

My sincerest thanks go out to John, Satinder and the rest of the RECORDER committee for all of their hard work and commitment.

The rebirth of the Journal has been another great achievement for Larry Lines and Satinder Chopra. It is no simple feat to compile and publish a complete journal of peer reviewed papers in what is often regarded as very much an industry society. I, and the CSEG, owe both Larry and Satinder, as well as the army of peer reviewers they have compiled, a thank you for all of their efforts and time devoted to bringing back a publication many of us had all but forgotten.

The website committee, reformed by my predecessor Cheran Mangat, wound up with maybe the most difficult task of the bunch. The rebranding process, which if you haven't heard about it yet you soon will, was dropped squarely in their laps. I'm still not entirely sure how the process started, but Cheran embraced and championed it, and again her efforts towards it served to make my job that much easier. Will McCarthy chaired the website committee this past year, and did an exceptional job of keeping the committee and the rest of us organized and informed, not only of the progress, but the process as well. The future will bring some more change as the RECORDER is prepped to become an online publication, and the website will continue to develop as a portal to the goings on of the CSEG. I think I leave this in very capable hands with incoming Director of Communications Jason Schweigert, and Assistant Director of Communications Meghan Brown.

In closing, I would like to thank Cheran Mangat for making sure things were in place to make my job easier, and I hope I have done the same for my replacement. As well, I would like to thank all of the volunteers for all that they do for the society. ## Managing Director's Report

This past year was one of tremendous growth, since the economic disaster of 2008. The following are some highlights for 2012:

- The GeoConvention was deemed a huge success, both technically and financially for our membership
- The DoodleTrain's overall attendance was up by about 25% over 2011 numbers. There were 20 courses provided and it still is considered a significant revenue stream for the CSEG.
- The RECORDER advertising was very similar to 2011. There was no drop in advertising.
- Memberships rose about 7% over 2011.
- The technical luncheons saw an average of just under 400 tickets per event sold. The Corporate Sponsor program continues to be a huge success as all 9 events were sponsored at \$1500.00 per luncheon. This helped the luncheons stay ahead of ever rising costs.

#### Looking ahead to 2013

- The second annual CSEG Symposium will be held in March. The first event saw close to 300 people attend.
- The CSEG took over operatorship of the GeoConvention, for 2012 and will be doing it again for 2013.
- The CSEG Foundation kicked off its fundraising campaign in December and nearly 400K has been committed to date. The drive will continue in 2013.
- GeoConvention appears to be on target to at least match its 2012 numbers both delegate wise and financially.
- CSEG should match if not exceed its 2012 membership renewals and remain constant with its corporate member program.
- Memorandums of Understanding with the EAGE and SEG will be signed this year to clear the way to offer more courses, workshops, etc. between the CSEG and these associations.

In closing I would again like to thank our executive for their support over the past year. Their commitment, along with the many volunteers serving on our committees, is the lifeblood of the CSEG and is unique among technical and professional societies in today's world. As our industry and the financial environment continue to change it is our commitment to the membership to provide the best service and information possible. The Executive and staff are cognizant of the immediate future and have well positioned the CSEG to handle the recovery without drastically altering its services.

### 2012 GeoConvention - Vision

The three societies, CSEG, CSPG and CWLS again came together to produce an excellent convention with GeoConvention 2012: Vision, and this year was another great success, with over 4,000 delegates enjoying some or all of the 5 day event.

#### **Technical Program**

With almost 250 oral presentations, over 100 posters, and 19 core displays at the ERCB Core Research Centre, the 2012 technical program had something to interest all delegates. Highlights included the honorary sessions for Drs. Eric Mountjoy and Cindy Riediger, as well as the CSEG special session on Thursday, which featured invited speakers from around the world addressing issues of interest to today's geoscientist. Audio visual issues have, for the most part, been eradicated, and as the venue becomes more familiar the remaining kinks regarding room and poster layout should be resolved.

#### **Special Events**

Dr. Michael Byers addressed delegates during Monday's luncheon with a keynote talk on sovereignty issues in the Arctic, which led to an interesting Q&A period, and LGen Romeo Dallaire addressed a capacity crowd on Tuesday with a thought-provoking and inspiring talk that prompted delegates to give a standing ovation, and which was the topic of discussion for the rest of the week among many in attendance. These events highlighted the fact that choosing engaging speakers is a keystone of the special events program, as it can affect the whole tone of the convention. The Core Meltdown was moved to the U of C campus in 2012, and was a hit with delegates. All agreed that having the larger function space for this event was a step in the right direction, and this will likely become the new venue for this event.

#### Registration

Registration was another key success of Vision 2012: as mentioned already over 4,000 delegates took part in this year's event, but this included over 3,000 paying delegates, as well as over 400 delegates who took advantage of the advance sale of complimentary exhibit floor passes. Student registration alone jumped over 80% over 2011 to a total of 373 delegates, with a further 78 student presenters in attendance. Returning events like the Challenge Bowl, as well as the new Student Travel Assistance Program and Industry/Student Luncheon will ensure this is a continuing trend.

#### **Exhibits**

The exhibit floor was sold out this year, with a waiting list of companies eager to attend in the future. Foot traffic was increased by bringing bars and food stations into greater prominence on the floor, and creating more of an event out of the evening receptions which took place Monday and Tuesday night. Exhibit Hours were extended in 2012 as the floor was once again open all day Monday – moving forward this seems like a popular change with exhibitors, and if hours were to be shortened at all it might be to an earlier close on Wednesday afternoon.

#### Sponsorship

Along with Exhibits, the Sponsorship Committee also exceeded budgeted revenues. In 2012 this committee worked to develop new opportunities to better fit the needs of industry partners, and expanded the advertising opportunities available. Some key successes:

#### 2012 GeoConvention - Vision

- Brought in a new technical session sponsor: Statoil; and new sponsorship by a legal/financial firm obtaining \$38,100.00 in new sponsorship dollars (returning sponsors contributed \$437,000.00). These amounts also account for sponsorship of Earth Science for Society.
- Had all social events sponsored for the first time in years!
- Good energy at the Icebreaker and at the Tuesday night event!
- New sponsorship initiative for university student assistance across Canada to defray their travel, lodging and meal costs. 18 students were funded.

#### Earth Science for Society (ESfS)

This program was extremely successful and well received. Dates, times, logistics have been fine-tuned over the past two years so that volunteers, exhibitors, and schools all said this was the best ESfS yet. ESfS boasted a strong line-up of exhibitors this year – very interactive and hands-on. Attendance is estimated as follows: Sunday: 400 general public Monday & Tuesday: 1300+ school attendees Monday & Tuesday: 200 convention delegates, homeschoolers, and general public 20 exhibits – at capacity 12 schools – at capacity by end of January 75 volunteers filled 155 shifts.

#### Volunteers

All requested convention week volunteer positions were filled by the 104 volunteers who provided their time, more than 1000 hours total, to the success of the convention. Our thanks to these people as well as the committee volunteers, from all three societies, that give their time year-round to ensure the success of this event. The convention would not be a success without their hard work and dedication.

This new approach will be continued with the intention of bring more technically superior focus articles in each of the RECORDER articles.

The CSEG website/communications committee was revived in 2011 in an attempt to update and improve the presence of the Society in an online world that is constantly changing and ever increasing in its importance. A team of hard working volunteers has laboured to keep the website up to date with content and information relevant to the membership.

#### The Online RECORDER

According to traffic statistics the RE-CORDER is one of the most commonly utilized sections of the CSEG website so improving its ease of use was one of this committee's top priorities. In order to do this we needed to move away from the cumbersome pdf delivery system and toward a web-article format that is more commonly used to deliver content these days. Adding this format allows

articles to be more searchable, be linked to related articles, have vastly superior visibility on major search engines, and faster download times. Back-end systems were made simple enough that a computer savvy volunteer member could run the system with a little training.

As an additional option for those that enjoy thumbing through a magazine we have added a flipbook feature that allows members to virtually flip through a copy of the RECORDER as if they were holding it in their hands. It looks great, keeps the traditional RECORDER format intact, and works well on tablets.

These updates set the RECORDER up for the future as online readership numbers increase.

#### Website Overhaul and Rebranding

Updating the look of the website turned out to be a vast undertaking. After consulting with the executive committee it was determined that in order to do it right we needed to completely overhaul the CSEG's brand imagery using a professional firm.

In the search for the right company, there were three rounds of solicitations, and

several graphic design/marketing companies were evaluated and interviewed before a final selection was made. Consultations with the executive committee were held throughout the process and a new logo, brand imagery, and taglines were agreed upon and were delivered under budget.

## Canadian Journal of Exploration Geophysics (CJEG)

The Canadian Journal of Exploration Geophysics (CJEG), the peer-reviewed journal of the CSEG, was revived in 2010 following an eleven year hiatus. Electronic issues of CJEG were published in June 2011 and June 2012 each containing six peer-reviewed papers. The editorial staff of CJEG in 2012 included *Larry Lines* and *Satinder Chopra* as Co-Editors. The CJEG Associate Editors are *Sven Treitel*, *Patrick Daley and Kris Innanen*.

As of February 2013, the journal has received 21 submitted papers. The statistics for these 21 submittals are as follows:

- 1. 12 papers have been published (6 in June 2011, 6 in June 2012 issues).
- 2. 1 paper has been accepted for the June 2013 issue.
- 3. 7 papers have been reviewed and are under revision.
- 4. 1 paper has been rejected as being inappropriate for CJEG.

All the journal papers are peer–reviewed in a timely fashion, with a desired turnaround time of less than 3 months. Papers are generally reviewed by 2-3 reviewers with technical expertise.

The PRINTMAN, Calgary provided typesetting/printing services for the CJEG, and has been found to be quite satisfactory in terms of quality and efficiency.

The criteria for submitted papers is outlined on the CSEG web site and are as follows:

- 1. The paper should be technically correct.
- The paper should discuss a relevant technical topic in applied geophysics which is of interest to members of CSEG.
- 3. Papers should have correct English grammar and spelling.
- 4. Papers should be clearly written for a general exploration geophysics readership.

 The text of papers should be in Word format. Images should have high quality resolution (300 dpi) in either .tif or .jpeg format.

Papers may be submitted to the Co-Editors, Larry Lines at Irlines@ ucalgary.ca or Satinder Chopra at schopra@arcis.com. While the journal has published 6 papers per year, we are constantly receiving papers from noted international geophysicists. Our goal is to publish 1-2 issues of the journal every year. To achieve this objective, we are encouraging papers from exploration geophysicists around the world. At present, copies of CJEG are available on the web site to all CSEG members.

### **CSEG Foundation**

#### **CSEG Foundation Overview**

The CSEG Foundation is basically the charitable operating arm of the CSEG. It is managed by a Board of Directors, is closely aligned with the CSEG, and boasts a volunteer group in excess of 10% of the entire CSEG membership. Each main committee has submitted a report (following). Significant highlights are:

- 1. University Student Outreach assisted a record 398 university students to become CSEG members and we are ramping up our outreach and assistance to university and technical students even more for 2013. Watch for that. Outreach to high school students is arousing more interest in geophysics, and we have also targeted science teachers in our activities across Canada. The public is getting exposure to the CSEG & geophysics by our presence at career fairs.
- 2. Our first-ever fund raising campaign, launched last September, has raised just under \$400,000 in personal donations and pledges, as a result of a pre-Christmas approach to members. The corporate campaign will move forward in 2013, and the members' campaign will continue. The CSEG Executive transferred \$250,000 into our account in mid-2012, raising our endowment to ~\$1 million. Our current campaign has increased that endowment as described. The generosity of a number of donors has been overwhelming. Watch for recognition of our amazing donors.
- 3. The Canadian Distinguished Lecture Tour (Lee Hunt last year and Don Lawton currently): this tour is continually expanding and improving, with Don Lawton's Tour reaching a prodigious 27 stops. By connecting with our Ambassadors and University Student Outreach Programs we are hosting receptions at a number of lectures and providing information on CSEG membership to students and CSEG members across Canada.
- 4. Scholarships were again very successful, and we instituted scholarships to technical school students. Watch for new scholarships in 2013 due to increased funding.
- 5. Travel Grants & Educational Subsidies were accessed by students from across Canada; we are increasing our budget for 2013 to assist even more students.
- 6. The CSEG Foundation has an overwhelming number of volunteers about 10% of our total CSEG membership. The

dedication of those volunteers and our high-profile Board of Directors has continued to make the efforts of the CSEG Foundation outstanding in virtually every way. The efforts and abilities of a core group of younger CSEG members is remarkable.

Each year we get a little better at what we do, through the organization and efforts of those volunteers and through funding – from you. Current terms of service are three year terms. The CSEG Executive has ultimate control of the CSEG Foundation through our articles of incorporation.

#### **CSEG Foundation Scholarship**

The CSEG scholarship committee began its fundraising efforts for 2012 scholarships in February 2012 with a presentation at the February CSEG luncheon. At the luncheon the committee introduced a new initiative to accommodate the increasing demand for Geoscience technologists in our industry. To supplement this, 2012 was the inaugural year for two \$1000 scholarships to be awarded to students at an academic institution in Canada in a program of Geoscience Technology. Efforts were made to promote the new scholarship as efficiently as possible and the scholarship currently appears on the admissions website for SAIT, NAIT, and BCIT. Committee members have worked closely with the faculty at SAIT and will continue to try and personally introduce students to the scholarship program.

A major goal of the committee in 2012 was to increase applications across Canada. This was achieved through a tremendous effort from the University Student Outreach (USO) committee to advertise the scholarship at conferences and CSEG events throughout the year. We would like to thank the volunteers with the USO for helping us increase our applicants by 50% from 2011. We plan on continuing this partnership with the USO and their ambassadors in the hope of consistently increasing applicants year after year.

We are happy to report that many of our long term sponsors continued their support and several companies and individuals contributed for the first time. The CSEG scholarship committee received funding from 19 Canadian–based Oil and Gas companies, service companies, individuals and trust funds to grant scholarships of \$2000 each to 19 deserving students from Universities across Canada, as well as supporting our new Geoscience Technology scholarship with two \$1000 scholarships awarded to deserving students. The scholarship committee would like to thank sincerely all of the sponsors for their continued support in helping geophysics students across Canada reach their academic goals.

Looking forward to 2013 the scholarship committee will continue to increase awareness to both industry sponsors and students across the country through the collaboration with the USO and CSEG. As our donations increase we will be looking to expand our footprint to recent high school graduates and promote the study of geophysics as early as possible. This will be accomplished by introducing 4 scholarships worth \$500 each to Canadian students graduating high school.

#### Canadian Distinguished Lecture Tour

Every year, the CSEG Foundation sponsors a national Canadian Distinguished Lecture tour by a distinguished member of the Canadian Society of Exploration Geophysicists (CSEG). The goal is to promote the science and application of geophysics to those working with, studying and interested in the science of geophysics and highlights a topic of current interest. The lecturer travels to approximately 20 locations across Canada between September and March. The venues are typically universities and geoscience institutions, including Geological Survey of Canada offices, but also occasionally more public venues. Congratulations and thanks to Lee Hunt, the 2011-2012 CDL, who spoke on Quantitative Interpretation, New Challenges, and Economic Value and Don Lawton, the 2012-2013 CDL, who is speaking on Post-earthquake Seismic Reflection Survey, Christchurch, New Zealand. This expanding program is very well received and enthusiastically supported by the venue hosts. The CDL tour is also incorporating post-talk networking events for local CSEG members, students, and faculty at some locations. These networking events are growing in sophistication, as are all aspects of the tour, and are used to further promote the CSEG and its programs across Canada. The CDL lecturer also publishes one or more tour diaries in the RE-CORDER, and typically also publishes an expanded technical article of the lecture in the RECORDER. Starting in 2011-2012, PDF files of the CDL lectures are posted on the CSEG website. The CDL committee created a Guidebook in 2012 that defines many aspects of the CDL tour, as well as the responsibilities of the lecturer, chair, hosts, and committee. #### CSEG Foundation Travel Grant and Learning Subsidy Program

The role of the Travel Grant and Learning Subsidy program is to assist CSEG members develop their professional geoscience knowledge or skills by supporting educational opportunities.

In 2012 the CSEG Foundation (CSEGF) Travel Grant and Learning Subsidy program gave \$7,504.91 to fund 52 students to travel and attend events such as the CSEG Convention, the SEG Annual meeting, PDAC, geophysical workshops, WUIGC, and CUPC. In addition, a \$750 travel grant was awarded to Susan R. Eaton for her trip with the Jackson School of Geoscience Antarctic Expedition in December 2012 (See the table below for more details).

The total 2012 grant amount was \$8,254.91 of the program's \$10,000. Our total grant amount would have been higher but a number of individuals cancelled their funding request for various reasons including the inability to secure sufficient funding.

A total number of 80 applicants would have received over \$10,800 in funding if not for the cancellation of the requests. It was reasons such as an increasing annual number of applicants and the inability of some groups to fully secure sufficient funding that lead the CSEGF Travel Grant and Learning Subsidy Committee secure a \$16,000 budget for 2013. The increased budget will allow the program to provide a higher \$/student ratio and better allocation of the funding budget to each of our application deadlines. Of the 2013 budget, the committee has a discretionary budget of \$1,000 to further assist applicants in need whose travel or learning costs may exceed both the standard funding guidelines and the resources available to them.

The CSEG Travel Grant and Learning Subsidy program continues to provide CSEG members the opportunity to develop, share and experience Geoscience in a variety of ways. We thank the CSEG Executive, the CSEG Foundation, the CSEG Outreach committee and our applicants for continuing to make this program a success.

In 2012, Louis Blinn chaired Schools Outreach and Annette Milbradt chaired Public Outreach. Our dedicated and enthusiastic volunteers attended 19 career fairs and assorted exhibitions in 2012, talking to students and the public about geophysics. We took our booth to Vancouver, Kamloops, Kelowna, Winnipeg, Saskatoon, Regina, Canmore, Edmonton, and Toronto, as well as to local venues in the Calgary area. With the booth we present the science of geophysics using PowerPoint presentations, interactive seismic displays and other teaching aids. Volunteers also responded to requests from schools for numerous inschool presentations.

From May 13th to 15th 2012, over 2000 students, teachers, and general public attended the third annual highly successful **Earth Science for Society (ESfS)** exhibition, run in conjunction with the Joint Annual Convention. ESfS had a strong line-up of 20 exhibitors and 75 volunteers who filled 155 shifts.

From October 2nd to 4th, CSEG-F Outreach hosted a record 164 students from Juno Beach Academy, the Career and Technology Centre, Henry Wise Wood, James Fowler and Centennial schools in Calgary and, for the first time, Canmore Collegiate, at the Seismic in Motion for Students field trip, where companies showcase their seismic acquisition technologies and procedures. Outreach volunteers visited the schools beforehand and briefed students about careers in geophysics, and prepared them for their day in the field. They also guided the students on site through various field stations, including the CSEG booth. At the booth, we provided participants with an integrated overview of the various parts of the program. We continue to receive positive feedback from participants and extend a big thank-you to all the volun-

teers and sponsors for their generous time and financial contributions to these important and successful events.

The University Student Outreach (USO) committee was led by Stephen Kotkas and Gabriel Solano. This year it brought the Outreach booth to five undergraduate conferences, including the Canadian Geophysical Union's convention for the first time, attended multiple university career fairs and presented several Best Geophysical Paper awards. The USO maintained its ongoing communication with students through e-mail and regular newsletters, connecting them with the Scholarship committee and the Foundation for travel grants; organized a student area at the convention; helped to deliver Geoskills 2012 for university students and junior geophysicists; provided networking opportunities; and ran the annual summer student field trip (Geophysics Industry Field Trip, GIFT) for 35 students.

The USO also maintained its cooperation with other organizations to help administer events such as AAPG's Imperial Barrel Award, CSEG/EAGE's student chapter talks, and APEGA's Alberta Student Energy Conference. The **Mentorship Program**, in its fourth year, continued its steady growth through 2012, accumulating more than 20 protégé-mentor pairings between university students and seasoned professionals.

The 2012 **Challenge Bowl** subcommittee was led by Gabriel Solano and supported by many volunteers, notably

The event's indefatigable host and moderator, Peter Duncan, once again navigated eight teams of competitors vying for an expense paid trip to compete in the Challenge Bowl finals at the 2013 SEG convention. Duncan's high energy style fed enthusiastic audience participation throughout the action-packed geoscience competition with competitors Naser Yousefzadeh and Kenneth D'Silva, representing the University of Calgary, taking the top spot.

CSEG Outreach members volunteered on the Honorary Address (HA) committee, chaired by Marissa Whittaker. This year's event took place in November, with the theme From Evolution to Exploration: Our African Journey. Dr. Trent Rehill, VP of Exploration for Kulczyk Oil Ventures of Calgary initiated the presentations by explaining the motivations of explorationists around the world, leading to the crossover point between the world of petroleum exploration and the topic of hominoid origins. #### DoodleTrain

The 11th running of the CSEG DoodleTrain Educational Training Week was staged November 12th to 16th, 2012. Over 420 members registered for a course this year, a return to the attendance numbers of past years, before the economic downturn of 2008/2009. A total of twenty (20) courses were staged during the week–long event. Seven (7) courses sold out before the close of registration in September. Twelve (12) new courses were introduced this year, four (4) of which comprised the seven (7) courses that sold out early.

This year saw many firsts for the DoodleTrain program. The DoodleTrain Committee branched out to expand its program with a pilot test, offering a webinar for the first time. Dr. Rob Stewart presented a 2-hour webinar on the topic of Converted Wave Seismic Exploration. The Committee also moved forward the Early Bird registration deadline from late September to June 30th. This required a lot of advertising and promotion to make members aware that the Early Bird Registration date was being moved forward by two and a half months. This proved to be highly effective and alleviated much of the panic that typically ensued during October, prior to staging the annual event. The committee was better able to plan and organize its affairs. Time crunches for office staff were also alleviated but not eliminated completely, however much progress was made. In 2012, the DoodleTrain approached industry recognized experts to create and build two courses specifically for the DoodleTrain, to be offered in 2012 and potentially in successive years. The Fundamentals of Survey course was offered by Neil Thompson and Bart Iverson. A second course entitled, Bits, Bytes, Seismic Data Formats: Pitfalls in Seismic Data Loading, was offered by Eric Keyser. One of these courses sold out early with the other one receiving strong support through member registrations. These courses specifically targeted non-professional members of the geophysical community, attempting to offer courses of interest for all society members, not just professional members. Much appreciation goes out to these people for taking the time and significant effort to build a course for the DoodleTrain. Also in 2012, the CSEG Executive decided that the DoodleTrain Committee would be responsible for offering courses at the annual convention in May. The Curriculum Sub-committee has already been working on this task and is planning to offer workshops on specific topics of interest to convention delegates. Some of the most popular courses that have sold out in previous years of the DoodleTrain may also be offered at convention time in May.

In 2013, the DoodleTrain Committee will re-visit the professional skills courses to see what can be done to make them more popular. Registrations caused the committee to cancel four (4) courses this year. The committee is considering lowering the

costs for these courses, dropping them from the program all together, or converting them into webinars. Whatever happens, it will be re-tooled for 2013.

So, 2013 will see the DoodleTrain committee offer courses and/or workshops at the convention, expand the successful webinar program and perhaps re-tool the professional skill courses. ## **CSEG Symposium**

The inaugural CSEG Symposium was held on March 22nd, 2012 at the Telus Convention Centre, Calgary. This event was initiated to honour Canadian geophysicists who have distinguished themselves through their outstanding contributions to our industry. This is primarily an industrial honour focused upon the honourees' manifold technological innovations, which may encompass many aspects of geophysics. Honourees are also selected based on their contributions to our geophysical society and its members' understanding of geophysical applications, particularly through technical leadership and the sharing of industrial knowledge. The idea of holding an annual CSEG Symposium found active support from the 2011 CSEG Executive, and so the plan is that each year this event will bring together some of the best known practitioners in the industry to deliver case study talks on the latest value add developments.

It was my distinct privilege to organize this inaugural event. I had the backing of some very enthusiastic individuals who were the members of the CSEG Symposium Committee, namely, Oliver Kuhn (Apoterra Seismic Processing Ltd.), Lee Hunt (Fairborne Energy Ltd.), Dave D'Amico (Talisman Energy Inc.), Penny Colton (Sensor Geophysical Ltd.), John Fernando (SAIT), Carmen Swalwell (Swalwell Resource Consulting Inc.), and Roger Smith (University of Calgary). For the inaugural symposium, our committee chose to honour Dan Hampson and Brian Russell, whose names are unarguably well-known the world over, through their software applications as well as their research, which have stood the test of time as well as the doom and gloom of the economic downturns. **Brian Russell,** from Hampson-Russell: 'Biot, Gassmann and Me'.

James Schulke, from Devon Energy: 'How conventional tools are used in unconventional plays'.

**John Eastwood**, from Imperial Oil: 'Cold Lake heavy oil reservoir geophysics – learnings and impact'.

**Bill Goodway**, from Apache Canada: 'Fit for purpose 3D Seismic and microseismic for geomechanical characterization of gas shales'.

Finally, **Marian Hanna**, from ION Geophysical: 'Geophysical applications – using geophysics for reserves and resources classification and assessment'.

**Keith Hirsche**, who has had a long association with the Hampson-Russell duo, talked about their professional lives and achievements during his more personal tribute speech.

The day went by quickly, with the eloquent and learned speakers keeping the audience's interest going, talk after talk. Once the regular talks were completed, both Dan and Brian were invited to say a few words. #### **INDEPENDENT AUDITOR'S REPORT**

I have audited the accompanying financial statements of Canadian Society of Exploration Geophysicists, which comprise the statement of financial position as at December 31, 2012 and the statements of revenues and expenditures and net assets and cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

#### Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian Accounting Standards for Not-for-Profit Organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

#### Auditor's Responsibility

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Canadian generally accepted auditing standards. Those standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified audit opinion.

#### Basis for Qualified Opinion

In common with many not-for-profit organizations, Canadian Society of Exploration Geophysicists derives revenue from memberships, registrations for luncheons and professional development courses and sponsoships, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, verification of these revenues was limited to the amounts recorded in the records of Canadian Society of Exploration Geophysicists. Therefore, I was not able to determine whether any adjustments might be necessary to these sources of revenue, excess of revenues over expenses, and cash flows from operations for the year ended December 31, 2012, current assets and net assets as at January 1, 2012 and December 31, 2012

These standards were applied retrospectively by management to the comparative information in these financial statements, including the statements of financial position as at December 31, 2011 and January 1, 2011 and the statements of revenues and expenditures and net assets and cash flows for the year ended December 31, 2011 and related disclosures. I was not engaged to report on the restated comparative information, and as such, it is unaudited
